## MASSACHUSETTS BUSINESS ROUNDTABLE WELCOMES TONJA METTLACH AS EXECUTIVE VICE PRESIDENT

Her career also includes experience in the non-profit sector and state government, where she served as Chief of Staff and Legal Counsel on two legislative committees including the Joint Committee on Labor and Workforce Development.

"Finding and keeping talent continues to be the top issue facing employers," said Jane Steinmetz, EY Boston Office Managing Principal and Chair of the Roundtable. "Tonja's knowledge of the workforce development system, employer needs and connecting the two will be an enormous asset to the Roundtable's members as well as policymakers grappling with these issues at the state level. Tonja is a highly respected expert and leader, and we are excited to welcome her to the Roundtable team." As Executive Vice President, Tonja's expertise in workforce issues and state public policy will focus on implementation of the Roundtable's "Talent Agenda to Drive Massachusetts' Competitiveness," a framework to drive the state's economic competitiveness by attracting, retaining, developing, and diversifying talent that reflects the top priority expressed by Roundtable members She will also be responsible for developing and advancing all Roundtable public policy strategies and initiatives, managing all internal and external communications, and undertaking organizational management responsibilities including serving as a liaison to external stakeholders, day-to-day operations, and member recruitment and engagement.

"I can't think of a better, more qualified person to lead the Roundtable's workforce and talent agenda than Tonja," said JD Chesloff, President & CEO of the Roundtable. "At the Roundtable, we are laser focused on the state's competitiveness and believe that competitiveness is fundamentally about people.
